PLACEMENT OF AN AGGREGATE OF 150,000,000 NEW ORDINARY SHARES IN THE CAPITAL OF THE COMPANY – COMPLETION OF THE PLACEMENT

The board of directors of the Company (the “**Board**”) refers to the Company’s announcements dated 20 December 2016 and 4 January 2017 (the “**Announcements**”) relating to the proposed placement of 150,000,000 new ordinary shares in the capital of the Company to Mr Seah Cheong Leng and Ms Ng Suk Sian as joint holders (collectively, the “**Placees**”) at a placement price of S\$0.05751 per placement share (the “**Placement**”).

Unless defined otherwise, capitalised terms used in this announcement shall have the meanings ascribed to them in the Announcements.

The Board is pleased to announce that the Placement has been completed today, pursuant to which the 150,000,000 Placement Shares were allotted and issued, and the issued share capital of the Company has increased by 150,000,000 Shares.

Following completion of the Placement, the total number of issued Shares of the Company has increased from 2,286,700,286 Shares to 2,436,700,286 Shares. The 150,000,000 Placement Shares are issued free from all claims, charges, liens, and other encumbrances and rank *pari passu* in all respects with the existing Shares, except that the Placement Shares will not rank for any dividend, right, allotment or other distributions, the record date for which falls on or before 9 January 2017.

The 150,000,000 Placement Shares are expected to be listed and quoted on the Catalist of the SGX-ST from 9.00 a.m. on 12 January 2017. The LQN is not an indication of the merits of the Placement Shares, the Placement, the Company, its subsidiaries, and their securities.

Further announcements will be made in due course as and when appropriate if there are any material updates on the Placement.
